We have received the final installment of \$2,500 of the generous grant of \$10,000 from the Alpha Omega Foundation for The ARK's Dental Clinic. Again, we greatly appreciate the Foundation's support for our mission to provide critically needed dental care for our clients.

As we noted in our proposal for renewed funding, The ARK's Dental Clinic provided more than 1,200 appointments for 355 different patients during the past year—36% more appointments than during the previous year.
